## IKOMITI YEPHONDO LENTSHONA KOLONI YAMAGAMA EENGGINGQI IKHWELO LOTYUMBO

Abantu abanomdla nabazibandakanya kumbandela wamagama eengingqi, ulwimi kunye nenkcubeko yoluntu lwaseNtshona Koloni bayamenywa ukuba batyumbwe abantu abafanelekileyo ukuba babe ngamalungu eKomiti yaMagama eeNgqingi yePhondo leNtshona Koloni. Ikomiti le iza kuhlala ixesha elingangeminyaka emithathu. Abatyunjwa kufuneka babe ngabemi boMzantsi Afrika, babe neminyaka engama-21 nangaphezulu ubudala kwaye babe ngabemi beNtshona Koloni abasisigxina.

Umsebenzi weKomiti yaMagama eeNgqingi yePhondo leNtshona Koloni kukucebisa iBhunga laMagama eeNgqingi eMzantsi Afrika (SAGNC) ngemiba ephathelene namagama eengingqi - oko kubandakanya ukuqingqwa kwawo, ukuqinisekiswa, iinguqu notshintsho kulawo magama eengingqi sele ekho. Abatyunjwa kufuneka babe nolwazi okanye ubugcisa obubodwa kwezi nkalo zilandelayo:

- ijiyografi / uzobo lweemephu
- Ubhalo-magama (iisistim zopelo lwamagama)
- Ulwimi nenzululwazi ngelwimi (ubugcisa kwiilwimi ezintathu ezisemthethweni zeNtshona Koloni)
- INkcubeko yeLifa leMveli, ezeMbal nezoKhenketho
